

CHARLOTTE PUBLIC SCHOOLS, FOOD SERVICE DEPARTMENT

Charlotte Public Schools, Food Service Program operates within the guidelines of the USDA National School Meals Program. The program is self-funding, which means we operate within a planned food service budget and do not use any general fund monies from the district.

CPS Food Service Department provides breakfast and lunch following meal patterns required by The Healthy, Hunger-Free Kids Act of 2010. Items from each food group on USDA's My Plate, including fresh vegetables and fruit choices, are offered daily to entice the many different tastes of our students.

What can a student expect at lunch time? Lunches are priced to include a protein item, whole grain item, 100% fruit juice, fresh fruit & vegetables and milk. To receive combo/lunch meal pricing, your child should:

- **Choose a required serving of fresh vegetables, fruits or fruit juice**
- **Choose at least 2 more food items from the menu, such as:**
 1. **A protein item (e.g. chicken, hamburger, etc.) or protein alternate (e.g. yogurt, cheese)**
 2. **A whole grain item (e.g. dinner roll, bun, pizza crust, etc.)**
 3. **Skim milk and low fat milk**

What can a student expect at breakfast time? Breakfast is priced to include a whole grain item, fresh fruit, 100% fruit juice and milk. To receive a reimbursable breakfast, your child should:

- **Choose a required serving of fresh vegetables, fruits or fruit juice**
- **Choose at least 2 more food items from the menu, such as:**
 1. **Whole grain items**
 2. **Low fat, skim milk,**
 3. **Meat/Meat alternative**

Eating foods from each of the food groups is the only way to assure students are receiving all essential nutrients. Eat your colors every day!

Applications for Free or Reduced Meals. New applications for free and reduced priced meals are required each new school year. Applications will be mailed out towards the end of summer, before school starts. They are available at www.charlottenet.org, Department tab, Food Service tab, Pricing, Free/Reduced Application or by calling our office, 541-5140. Please complete and return as soon as possible to your child school office or mail to CPS Food Service Department, 378 State Street, Charlotte, Michigan, 48813. Notification will be returned to each family on their status of meals.

Free and reduced applications are accepted at any time during the school year.

Menus are available monthly on www.charlottenet.org and delivered home with your Elementary Student and Upper Elementary Student. Menus will also be available at all school offices for your convenience.

POS Computerized Debit System. CPS operates a debit system for your child's meals at school. Accounts are set up by families with sales being drawn from your account. Payments can be deposited by cash/check/money orders on your account. Envelopes will be available at Elementary level and CUE level for payments. Payments can be made at point of sale by your student or returned to school with your child. We strongly encourage you to maintain a minimum balance of \$10 in your account at all times to avoid the possibility of a hold on lunch and breakfast purchases. **Electronic deposits** can be made on your account at www.charlottenet.org → Parent tab → efunds. Create your own user name and password and call our office for your family pin number, 541-5140. To view what your child is purchasing and account balance, please call Sue Braden at 517-541-5111, for access information.
